**VILLAGE OF NEW MARYLAND
PLANNING ADVISORY COMMITTEE BY-LAW
BY-LAW NO. 01-2021**

WHEREAS the *Community Planning Act* S.N.B. 2017, c.19 ("the Act") was proclaimed and came into force January 1, 2018;

AND WHEREAS under Section 141 of the Act, the "former Act" means the *Community Planning Act*, chapter C-12 of the Revised Statutes, 1973;

AND WHEREAS under Section 144 of the Act a by-law made under the authority of the former Act that was in force immediately before the commencement of this section shall be deemed to have been made under the Act and is valid and continues in force until amended or repealed, to the extent that it is not inconsistent with the Act or a statement of provincial interest;

AND WHEREAS under Section 149 of the Act a person who was a member of a Planning Advisory Committee appointed under Section 12 of the former Act that was in force immediately before the commencement of this section shall be deemed to have been elected under Section 3 of the Act and continues in office until such person resigns or is reappointed or replaced;

AND WHEREAS the Council for the Village of New Maryland proposes amendments to *By-Law No.1, A by-law of the Village of New Maryland to establish a Planning Advisory Committee*, and amendments thereto;

THEREFORE, BE IT ENACTED by the Council for the Village of New Maryland under the authority vested in it by the Act, as follows;

The Council for the Village of New Maryland under the authority vested in it by the *Community Planning Act*, S.N.B. 2017, c.19, and amendments thereto, enacts as follows:

1.0 TITLE

- 1) This by-law may be cited as the "*Village of New Maryland Planning Advisory Committee By-law*".

2.0 APPLICATION

- 1) Pursuant to Section 3 and Section 5(1)(b) of the Act, a Planning Advisory Committee consisting of six (6) members is hereby established for the Village of New Maryland
- 2) There shall be at least one (1) member who is a member of Council.
- 3) No more than two (2) members appointed to the Planning Advisory Committee may be members of Council.
- 4) This by-law comes into force on the date of registry in the York County Land Registration Office, in accordance with Section 112(1)(b) of the Act.

3.0 POLICY ON PROCEDURE AND PROTOCOL

- 1) The Planning Advisory Committee shall adopt a "*Policy on Procedure and Protocol*" and may from time to time amend the policy so long as the provisions therein do not conflict with the Act, the *Local Governance Act*, or the by-laws of the Village of New Maryland.

- 2) The *Policy on Procedure and Protocol* shall be reviewed by the Planning Advisory Committee at least once every four (4) years.

4.0 REPEAL AND TRANSITION


- 1) *By-law No. 1, A by-law of the Village of New Maryland to establish a Planning Advisory Committee*, adopted on September 18, 1991, and amendments thereto, is hereby repealed.
- 2) The repeal of *By-law No. 1, A by-law of the Village of New Maryland to establish a Planning Advisory Committee* shall not affect any penalty, forfeiture or liability incurred before such repeal or any proceeding for enforcing the same completed or pending at the time of repeal; nor shall it repeal, defeat, disturb, invalidate, or prejudicially affect any matter or thing whatsoever completed, existing or pending at the time of repeal.


