## **Expression of Interest to Volunteer for the Village Planning Advisory Committee**

The Village of New Maryland Planning Advisory Committee (PAC) is responsible for advising Council on matters related to land use planning and development. The PAC reviews and makes recommendations and approvals on development proposals and applications for amendments to the Municipal Plan and the Zoning By-Law, subdivision applications, temporary use permits, similar use approvals, and variances. The Committee also contributes to exercises relating to long range planning which assist Council and staff in managing growth in a manner consistent with the Municipal Plan By-law and Zoning By-Law standards.

Through the authority granted in the New Brunswick Community Planning Act, the PAC of the Village of New Maryland is appointed by the Village Council. The PAC consists of six (6) voting members including village councillors and village residents. The Development Officer and Recording Secretary have a voice at the meetings but are non-voting members of the Committee. There are varying durations on membership terms and the number of eligible terms, dependent on local by-laws or provincial legislation, but are usually one to three years in duration with the option for re-appointment.

A list of qualified applicants will be compiled for Village Council's consideration for any current membership vacancies on the Planning Advisory Committee. Applicants may be invited to attend a brief personal interview with Council as part of the candidate selection process.
